



## 2017 TD Saturday Market Youth Booth Application

Calling all young entrepreneurs! Does your child have a skill that they would like to showcase at the TD Saturday Market? The market invites local youth to apply as a participant of its Youth Booth! The Youth Booth provides young entrepreneurs with the opportunity to showcase and sell their work to market shoppers.

Interested young entrepreneurs will be designated one Saturday during the 2017 market season for a fee of \$10, which includes a 10'x10' tent space and one 6' table. Once dates are scheduled, each young entrepreneur will also be listed on the market website. *This opportunity will be extended only once per entrepreneur during each market season.*

### Rules and Regulations

- **All Youth Booth participants must be local residents between the ages of 8 and 16 and produce original, unique, high quality, safe items which bring some added value to the TD Saturday Market. All products must be the actual work of the crafter and produced within 100 miles of Greenville, SC. No commercial items, no imported items, no manufactured items, and no second hand items shall be resold.**
- **Booth must be staffed for the entire time the market is open and each child MUST be accompanied by an adult (8:00 a.m. – 12:00 p.m.)**
- **Attendance:** Only one young entrepreneur will be selected to be at the market each week. If you have been selected to participate, please make every effort to keep the commitment. One week (7 days) notice is required if you will not be able to attend a committed Saturday. Failure to be present on a committed date and/or give notice of absence may result in the forfeiture of your privilege to participate in the TD Saturday Market. The Market is a rain or shine event and will only be cancelled as a last resort.
- **Booth Set-up:** The City will setup the tent and table. Vehicles are allowed onsite to unload only. Vendors are encouraged to be creative in decorating their booths/tents.
- **Vendor Parking:** There is plenty of free parking for TD Saturday Market participants near the market site. Pay close attention to the street and parking lot regulations for you may be towed at your risk and expense. All parking must be in a marked parking space outside of the event site. No parking is allowed in any median or lane of traffic (even if the road is closed.)

- **Booth Take Down:** No vehicles will be allowed on site until 10 minutes after official market closing time. Please wait for TD Saturday Market staff or police to notify you of when it is safe to enter. Youth Booth participants must clean up the area around their booth before leaving.
- **Policies for ALL Vendors:**
  - The TD Saturday Market standard weekly space includes one 10x10 tent and one 6' table.
  - Please come prepared with your own site supplies (extra tables, chairs, tape, tacks, scissors, etc.).
  - Per City ordinance, no pets are allowed in the permitted market area – with the exception of service dogs.
  - The market reserves the right to refuse participation to vendors who do not comply with market regulations or do not meet market standards which include, but are not limited to, following all local, city, state and federal laws and regulations.
  - The market is not liable for any injury, theft or damage to either the buyer or seller, or their property, arising from or pertaining to preparation for or participation in the market.

### TD Saturday Market Information

**Dates:** Saturdays, May 6 - October 28 (except October 15)

**Hours of Operation:** 7:00 am - Vendors arrive and set-up at event site

7:45 am - All vehicles must be off event site

8:00 am - Market Opens

12:00 pm - Market Closes

12:10 pm - Vendor vehicles may return to event site for loading once given approval by City police or Market staff.

**Location:** Main Street between Court Street and Washington Avenue

The TD Saturday Market Youth Booth participants may not sell material or hand out information that:

1. Is edible or living
2. Is false, misleading or deceptive
3. Does not relate to the market
4. Is libelous
5. Promotes unlawful or illegal goods, services or activities
6. Implies or declares an endorsement by the City of Greenville of any goods, services or activities
7. Contains any obscenity, or sexual conduct of any kind (obscenity is defined as any communication, picture, image, graphic image, or other matter that the average Greenville citizen, applying contemporary standards, would find, taking the material as a whole, appeals to prurient interest and whether it depicts or describes, in a patently offensive way, sexual conduct)
8. Promotes the sale or use of tobacco or tobacco-related products
9. Supports or opposes a political candidate, issue or cause
10. Supports or opposes a religion or religious denomination, creed, tenet or belief, including information or material that supports or opposes atheism or agnosticism.
11. Is determined by the Market Committee to be inconsistent with the goals of the TD Saturday Market and would interfere with the primary purpose of the market.
